Dear Loyola Student and Family,

The Bursar staff is delighted to welcome you to Loyola! Our office is responsible for the billing and receipt of payments of tuition and fees and we would like to familiarize you with some of our services.

Billing

Electronic bills (e-Bills) are generated on the 15th of every month and provide the last 30 days of account activity. E-Bills are sent to students via their campus email and payments are due on the 5th of the following month. We do not send paper bills so please make certain your student provides you Parent/Guest Access.

Payment Methods To learn more go to **[Luc.edu/bursar/payment](https://luc.edu/bursar/payment)**.

- **E-Check:** to submit payment through LOCUS by providing your checking or savings account number.
- **Installment Plan (iPlan):** to divide your balance over monthly installments from 12 to 9 months. The last day to enroll and first payment due date for a 12-month plan is **June 5, 2025**.
- **In-Person Payments** can be made with cash, check or money order at the Lake Shore, Water Tower or Health Sciences Campuses Bursar locations.
- **Mailed Payments**, with the student's LID included, can be sent to:

- **Credit Card Payments** can be made via LOCUS. A 3% convenience fee will be assessed by TouchNet.

Student Health Insurance

Students are automatically billed \$3,684 for Loyola's health insurance plan. Students covered by another policy, may opt out of Loyola's health insurance by submitting a waiver in LOCUS under Financial **Account>Student Health Insurance** by October 1, 2025.

Dewar Tuition Insurance

Students are automatically billed \$224 for tuition insurance if they do not opt out at the time of class registration. Tuition Insurance covers 75% of term tuition and fees if a student withdraws for medical reasons. Parent/Guest Access

Parent/Guest Access ensures compliance with the Family Education Rights and Privacy Act (FERPA) and provides permission to parents to receive e-Bills, view the student account, waive health insurance, view and create a payment plan, view a 1098-T, and communicate with offices on campus.
